How to use

Washing Machine Cleaning

- Add 500g to the drum and run on a hot wash once a month.
- Laundry – water softening and stains: Add 25 to 75g depending on water hardness to each wash and use the soft water dose of your detergent.

Sinks and Drains

- Use with hot water regularly to keep free of odours and prevent blockages.

Pots and Pans

- Use with hot water to remove grease and stubborn deposits.

General Cleaning

- Dissolve in hot water and use on worktops, ovens, extractor hobs, etc.

How it is promoted

- Cleans sinks and drains. Cleans and freshens washing machines. Use in laundry. Plus, many more uses.

Warnings

- Do not use soda crystals in contact with aluminium
- Avoid varnished and lacquered surfaces
- Not to be used in drinking water
- Users with sensitive skin should avoid prolonged contact with highly concentrated solutions of soda crystals
- Store in a cool dry place below 25 degree celsius
- Causes serious eye irritation – keep out of reach of children – wash hands thoroughly after handling. Wear protective gloves/ protective clothing/eye protection/face protection.
